

**Mr Gas CASH PLUS Program "Free Gas For a Year" Contest (the Contest") OFFICIAL RULES TERMS & CONDITIONS:** Contest begins April 23rd, 2018 (01:00:00, ET) and ends September 10th, 2018 (23:59:59, ET).

## 1. HOW TO ENTER
